My bank account will be debited by the 10th day of the month or next business day. This agreement will remain in effect until Texas Disposal Systems, Inc. has been notified in writing to discontinue the agreement or the account is closed and paid in full. I, the customer, am responsible for notifying Texas Disposal Systems, Inc. of changes to my autopayment information. Texas Disposal Systems, Inc. is not responsible for double charges if I, the customer, make a second payment after my autopay account is to be charged. Texas Disposal Systems, Inc. is also not responsible for contacting me due to declined autopay information.

For Pre Paid Charges:

I pre-approve an additional charge for such items as extra pick-ups and/or additional services that are not listed on my contract as part of regular monthly trash pick up. I have the right to dispute any unauthorized charge to my account. I understand that I will be charged for the delivery, termination, pre-determined hauls, and rental along with applicable fuel surcharges, franchise fees, and sales tax. I authorize the total to be charged to the account provided above. **An estimated charge has been included on an additional spreadsheet showing the information included in the charge. I have initialed and returned the estimated charge information with this form. Changes to fuel surcharge, over-weight fees, etc. may be included with the final payment amount, over or under the estimated charge.**

My bank account or credit card will be debited immediately after all paperwork concerning this transaction has been completed.
